It was rewarding that the Professional Associations (PAs) worked together with RAMP to inform the representation RAMP made to DEFRA at the end of May, and then wider consultation meetings attended by the PAs and RAMP in July. There has been no feedback to date from DEFRA on those meetings, but we believe a public consultation is due before the end of 2025.

The discussions at DEFRA implied that it was desirable that the Veterinary Allied Professions (VAPs) do come under a statutory regulatory structure within the wider veterinary healthcare model. RAMP believe that the standards we have put in place would create the foundations of competent regulation of Chiropractic, Osteopathy and Physiotherapy (MSK) practitioners in animal care.

The challenge is to ensure all registrants understand the responsibility they accept as statutory regulated professionals. RAMP has strongly advocated for the MSK professions that autonomous practitioner status is essential for the effective integration of these practitioners into animal practice. RAMP will support all registrants to maintain the level of professionalism expected but it is now the responsibility of all registered practitioners to fully comply with the voluntary regulatory processes in place to evidence the confidence RAMP has in the industry is justified.

I am sure you are all up to the task!

BVA LIVE & BEVA CONGRESS 2025

The RAMP team attended both the BVA live and BEVA Congress. The lack of regulation in our industry has meant there is some confusion over the level of practice RAMP registrants can provide. Communication at these events when everyone has time to talk is instrumental in assuring vets that if they have any concerns about the practice of a registrant, or questions about the MSK sector they can speak to RAMP.

PUBLIC EVENTS

This year to increase awareness RAMP attended several public events. So, in 2025 we attended the National Equine Show, Paws in the Park; Sussex, Edition Dog Live and Dogfest Bristol and Yorkshire. The aim was to involve registrants in the hosting teams and engage with the animal-owning public. These events are well attended, and we had lots of positive exchanges with both the public and other exhibitors and no doubt informed those who came to speak to us.

However, most of these events are expensive to attend, and so the pilot of 2025 revealed that it may be more productive to spend RAMP limited funds on a social media professional to promote RAMP profile with the public for 2026. RAMP will still attend the events we are invited to provide information about RAMP and will still be looking for interested registrants to support the RAMP Councilors at the events we do attend.

BRITISH FARRIER AND BLACKSMITHS ASSOCIATION



RAMP was grateful to the British Farrier and Blacksmith Association (BFBA) committee for the invite to attend their annual conference Farriers Focus event on September this year. Collaboration with the Farriers is one of the most productive elements for MSK professionals in equine practice for the benefit of movement pattern rehabilitation. For best practice this relationship needs to develop to extend from individual practitioners to the professions as a whole.

Some Farriers were concerned that some MSK practitioners discussed foot balance with the owners rather than with the Farrier and therefore misunderstandings were created. It was discussed that MSK practitioners should be discussing joint aims with the Farriers, so each professional could contribute their specific skillset. There were useful conversations with farriers which revealed that communication needs to go both ways and hopefully we can continue to discuss this at future events.

RAMP was delighted that registrants Sarah Read and Hannah Crook joined us on the stand. Sarah said: *Over the course of two days, we had some valuable conversations with farriers about how we can better open and maintain lines of communication between farriers, MSK professionals and other members of the multidisciplinary team. Many conversations were sparked by a general frustration with the lack of regulation within the MSK industry and the knock-on effect on standards of care and communication.*

By discussing the work RAMP is doing in their tireless quest for regulation and autonomy and the stringent qualification, CPD and insurance requirements for RAMP members, we were able to allay some concerns and provide delegates with the necessary resources to enable them to make contact with and refer clients to RAMP registrants with confidence.

I felt RAMP was well received at the conference and came away with the overwhelming impression that MSK industry regulation would be a welcome progression from farriers' points of view.

RAMP hope that volunteer registrants will come forward to assist at these events when the opportunities arise in 2026.

WHO DO YOU THINK YOU ARE? ALLIED PROFESSIONAL OR PARA-PROFESSIONAL

RAMP believe that regulated and degree level practitioners belonging to a profession should be given the title Professional Allied to Veterinary Medicine or Allied Professional. Traditionally in the veterinary healthcare sector our professions have been referred to as Para-professional (or even non-qualified people) which seem like people who work alongside professionals. It is so important that we all, gently and respectfully ask to be referred to as an Allied Professionals and always refer to yourself and colleagues with the same title.

It was disappointing not to be considered in the initial proposals despite the extensive contribution from our Council at each stage of the consultation. RAMP have made a response to this effect.
